The Applicant agrees to the following conditions:

1. To hold the County and its agents harmless and free from all damages or suits arising from said excavation or work connected with same.
2. That all work from initial boring until final closing will be completed between the hours of 9:00 a.m. to 4:00 p.m. local time Monday to Friday (except holidays) and that no work will be held over the weekend or holidays, unless otherwise agreed to by the Director / County Engineer.
3. To include with the application a sketch (hand drawn acceptable) of the proposed work zone to detail all significant features in the immediate area, as may be required by the County of Northumberland.
4. To provide a Traffic Control Plan, as applicable.

5. To provide copies of locates.
6. To provide a copy of insurance, naming the Corporation of the County of Northumberland as an additional insured and provide proof of liability insurance in the minimum amount of \$ 5,000,000.
7. Obtain permission from private property owners, if necessary to access their property.
8. To abide by all rules and regulations of the various labour acts affecting trenching, shoring etc..
9. To erect and maintain proper barricades and to light same when necessary to protect the traveling public.
10. To conduct the location of and to protect any and all existing underground utilities from damage that may occur as a result of the pit excavation.
11. The disrupted area to be restored as nearly as practical to original condition. This includes new sidewalk, curbs sod etc. if applicable.
12. The applicant agrees to pay for any maintenance required by the undertaking for the period of one year from the date of completion.
13. The minimum depth of cover to be maintained within the right of way is 1.2 metres.
