- 1) Review and approval of January minutes and documents
 - a. Data Inventory, Strategy Inventory, and Network Inventory will be finalized once any submitted changes have been completed
- 2) Welcome to Jenny Whyte, Collaborative Design Strategist
 - a. Presentation of priorities that have been identified through community and agency consultation and data analysis
 - i. Service Provider Survey results: Thank you for your input! We took the top 10 priorities identified by the community, and asked this table to rank them in order of highest need from the perspective of the service agency. When these rankings were collated, we found that the top 5 service provider priorities reflect the same 5 priorities identified by members of the community, indicating consensus on the

areas of greatest need from the larger list of priorities. After review, we collapsed a few of the overarching categories into one priority, in order to better focus the targets of the plan. For example, 'Poverty/Income' and Employment were collapsed into one category of Poverty/Income/Employment. We also removed "access to services" as a single priority, and instead have included it as a consideration that should be reflected in each priority. This leaves the top 4 priorities (in no particular order), of mental health, substance use and addictions, housing and homelessness, and income, poverty, and employment.

- b. Facilitated collaborative session to identify objectives for each priority
 - i. Brainstorming session to review the levels of response as required by the Ministry
 - ii. Identified current activities, strengths, and gaps in service within the context of the four levels of response
- 3) Updates from team members
 - a. Rebound and CPS: Provided an overview of the CUIP program (Collaborative Intervention Under 12 Program), which targets those at greatest risk. Chief Vandegraaf noted that 7 officers have signed up to be mentors for 2021.
 - b. Northumberland County: Offering virtual Bridges Out of Poverty training on February
 18th. There are still spaces available.
