• The Family Checkup program is launching, screening for people under the age of 7 will commence.

ii. Northumberland Hills Hospital Community Mental Health

- The walk-in on Tuesdays and Thursdays continues to be open and available including access for youth through Rebound.
- Working with Northumberland County to support their homelessness worker in connecting with community members experiencing homelessness and mental health. Currently there is a focus on connecting throughout the county into rural centers etc.

iii. Northumberland United Way

- Announcement that Maggie Darling will be taking over Bobbie's work with the CSWB Collaborative to support community safety initiatives.
- Continuing with ongoing Community Impact Work.
- The use of rolling grants has launched through united way, further information is available on their website.

iv. Community living Northumberland

 The Northumberland Family Network is setting up a BBQ for families to come together and offer support, further information will be shared on the SharePoint site.

v. Family Health Teams of Northumberland

- Further expanding after hours availability through the family health team physicians.
- Currently working on catching up on backlogs due to the pandemic including pap test screenings.
- Moving towards a digital health platform and rolling out online booking with physicians.
- Ongoing vaccination appointments are available.
